**Preliminary remark.** The 'special donation' is from an individual GMS has helped with financing his court case, which is ending in an amicable settlement. It is not 100% settled yet, but a first payment has been made. This individual has made this donation. More will be coming. It will be clear that the Tax Office might see this as Income. However, GMS did not act as attorney. The individual GMS has helped financially wants to give GMS something to be able to continue its work. That makes it a donation. Moreover, this is an exceptional case and situation. So: Donation.

On 30 June 2026 there was a monthly **deficit** ad \$ 151.-. The deficit will be debited to the General Fighting fund. The 'base-line' (general reserve-fund) remains at \$ 10,000.-.

There are now 7 court cases *pending* funded by GMS, *three* started in 2025 and *four* in 2026 (two about industrial accidents and one about the granting of Dutch nationality in 2025; one about eligibility for an AOV-benefit for the spouse of a pensioner in March 2026 and one about the principle that the Custody Board cannot give a second opinion about its own primal recommendation – another independent body or person must be appointed by the Court for the second opinion. This last case was added in April 2026. In May and June 2026 two more cases were funded by GMS. One labor case about exploitation of an immigrant live-in domestic worker. And another case about the government (Ministry of Social Affairs) deducting money from the social benefit this same Ministry pays to Old Age Pensioners to raise their incomplete AOV-Pension to the level of a complete AOV-pension. The deduction comes into effect, if the Old Age Pensioner works for money on the side. That is not fair. The case has been submitted to the Court in June 2026.

In April 2026 an appeal was lodged in one of the industrial accident cases (see 23<sup>rd</sup> GMS Court Case). GMS will soon have to pay for a medical report in this case (estimated cost +/- 1,000.-).

Another case is also pending. It has to do with the disproportional consequences of a so-called 'residence-gap' for immigrants. The IND (immigration office) has been contacted in an effort to reach a settlement. We have received word that the IND will not settle this case. So, we are preparing to take this case to Court. To do that, we must first receive a 'rejection decision' from the government that can be used to start this principled case. Will update.

Together with the Art-School/Art Gallery 'Sobremesa', GMS has organized the first public "Art & Justice Auction" on 16 May 2026. It was a brilliant success, both financially and public-relations-wise. This initiative will be continued, as it has shown to be effective as a permanent yearly funds-raising activity for GMS, making it possible to continue its work for years to come.

Bank-Balance as at 30 June 2026 was: **\$ 46,727.52**. Bank-balance as at end May 2026 was **\$ 46,878.92** → Monthly *deficit* for June amounted to (rounded off) **\$ 151.-**.

Note. There is only one sub-tenant now. So, we only have to reserve \$ 250.- for possible repayment for when the remaining sub-tenant or GMS itself terminates the rental agreement. *The rental agreement has in the meantime been terminated by GMS as at 31 August 2026.*
